On 31 January 2015 (“First Date of Sale”)

The order of submission of Registration of Intent* will be used to determine the order of priority for residential properties selection. Details are as follows:

1. On the First Date of Sale, person(s) or company(ies) who has already submitted a Registration of Intent (date of printing: 26 January 2015) (a “registrant”) (or a named attorney of a registrant with a power to sign Preliminary Agreement for Sale and Purchase and other documents relating to the purchase of specified residential property(ies) in Cadogan pursuant to a duly executed Power of Attorney to the satisfaction of the Vendor) shall attend the Sales Office in person between 9:30 a.m. and 10:15 a.m. (the “attending time slot for registrants”). The registrant must bring along a copy of his/her/its/their Registration of Intent and their H.K.I.D. Card(s) or Passport(s) (as the case may be) (for personal registrant) or a copy of Business Registration Certificate and Registers of Directors, the director’s H.K.I.D. Card(s) or Passport(s) and the company chop (for corporate registrant), or if the registrant is represented by an attorney, the attorney must bring along a copy of the relevant Registration of Intent, the original Power of Attorney, the attorney’s original H.K.I.D. Card or Passport and a copy of H.K.I.D. Card or Passport of the registrant. Registrants whose identities have been confirmed and verified by the Vendor shall be eligible for viewing the specified residential properties and flat selection. Registrants who arrive at the Sales Office at any time after the expiry of the attending time slot for Registrants will not be entertained.
2. Registrants whose identities have been verified are invited and advised to view the specified residential properties from 9:35 a.m. to 10:25 a.m. on the First Date of Sale. Any registrant who has viewed and selected a specified residential property would be required to confirm this in writing before signing the Preliminary Agreement for Sale and Purchase. If any registrant declines to view the specified residential property(ies) notwithstanding that the Vendor has made the specified residential property available for viewing by the registrant and such registrant has selected a specified residential property, such registrant shall confirm the same in writing prior to the signing of the Preliminary Agreement for Sale and Purchase.
3. Flat selection will take place at or after 10:30 a.m. on the First Date of Sale. The registrants shall proceed to select the specified residential properties in the order of priority according to the time of submission of Registration of Intent.
4. Each registrant can submit a maximum of two Registrations of Intent. When it is a registrant’s turn to select residential property, the number of residential property that the registrant may select in respect of a Registration of Intent shall not be more than the number of specified residential properties which the registrant intends to purchase as indicated in that Registration of Intent. Before entering into the Preliminary Agreement for Sale and Purchase in respect of a residential property, the registrant may

request the Vendor on spot to add other party(ies) as joint purchaser(s).

After the completion of the selection of the residential properties by the registrants as aforesaid, the sale of the remaining residential properties (if any) will be on a first come first served basis (but the order of priority in the selection of the remaining residential properties among all potential purchasers arriving within the first 5 minutes immediately after the selection of the residential properties by the registrants as aforesaid is to be determined by a balloting). In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method.

The Vendor also reserves its right to revise the time of viewing and/or selection of residential properties in accordance with the progress of confirmation and verification of identities of registrants or attending other necessary procedures without further notice.

On 1 February 2015 and thereafter:

The remaining residential properties (if any) will be sold on a first come first served basis. In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method.

2015年1月31日（「該出售首日」）：

單位揀選之優先次序將以遞交購樓意向登記表格*之先後次序決定。詳情如下。

1. 已經遞交購樓意向登記表格(印製日期：2015年1月26日) 之人士或公司（「登記人」）(或登記人的受權人（該受權人須根據由登記人妥為簽署並令賣方滿意的授權書獲權力簽署關於購買加多近山的指明住宅物業的臨時買賣合約及其他文件）)須於該出售首日上午9時30分至上午10時15分（「登記人報到時段」）攜同其「購樓意向登記表格」副本及攜同其（如登記人屬個人）香港身份證或護照（視屬何情況而定）或其（如登記人屬公司）商業登記證副本、董事名冊副本、董事身份證或護照及公司印章，或如登記人由受權人代表，受權人須攜同相關購樓意向登記表格副本、授權書正本、受權人的身份證或護照正本及登記人的身份證或護照副本，親臨售樓處，經賣方確認並核實身份後方可享有參觀指明住宅物業及選購物業資格，於登記人報到時段屆滿後任何時間才到達售樓處的登記人將不獲受理。
2. 經核實身份的登記人被邀請及建議於該出售首日上午9時35分至上午10時25分參觀指明住宅物業。任何登記人如已參觀及揀選指明住宅物業，必須在簽署臨時買賣合約前以書面確認已參觀指明住宅物業，如即使賣方已開放指明住宅物業供登記人參觀，但登記人婉拒參觀該等物業，並已揀選指明住宅物業，登記人亦須在簽署臨時買賣合約前以書面確認。
3. 選購住宅物業程序將於該出售首日上午 10 時 30 分或之後進行。登記人將根據其遞交購樓意向登記表格的次序選購指明住宅物業。
4. 每名登記人最多可遞交 2 份購樓意向登記表格。當輪到登記人揀選住宅物業時，登記人就一份購樓意向登記表格可揀選的住宅物業的數目不可多於其於該購樓意向登記表格內所填寫意欲購買指明住宅物業之數目。於簽署臨時買賣合約購入住宅物業前，登記人可即場要求賣方加入其他方作為聯名買方。

登記人以上述形式認購完畢後，尚餘之住宅物業(如有)將以先到先得形式發售，但上述登記人揀選住宅物業完畢後首 5 分鐘內到達之所有準買家，則以抽籤決定揀選尚餘住宅物業之優先次序。如有任何爭議，賣方保留最終決定權而以任何方法自行分配任何該指明住宅物業予任何有意欲購買的人士。賣方保留最終決定權因應確認和核實登記人身份和其他程序之進度而調整參觀及/或揀選住宅物業時間，並不作預先通知。

(a) The time and manner for the submission of the Registration of Intent and the documents and materials required, etc. are specified in that form. Please refer to the form of the Registration of Intent for details. Generally:

遞交購樓意向登記表格之時間和方式及所需文件材料等於該表格中有所說明。詳情請參閱購樓意向登記表格。概括而言：

(i) In addition to copies of specified identification documents, cashiers' order(s) must be submitted together with the Registration of Intent. The number of cashiers' order(s) that a registrant shall submit is the same as the number of residential property(ies) that the registrant intends to purchase. The amount of each such cashiers' order shall be HK\$200,000. Each such cashiers' order shall be payable to "Deacons".

除指明的身份證明文件副本外，遞交購樓意向登記表格時必須同時遞交銀行本票。須遞交之銀行本票數目與登記人意欲購買之住宅物業數目相同。每張銀行本票金額為港幣\$200,000。銀行本票抬頭人為“的近律師行”。

(ii) The completed Registration of Intent shall be submitted by the registrant (or its duly appointed director (applicable to a corporate registrant)) personally at the Sales Office during the period on 26 January 2015 (from 7:00 p.m. to 8:00 p.m.), or from 27 January 2015 to 30 January 2015 (from 11:00 a.m. to 8:00 p.m.).

(b) The sale of the residential properties is subject to availability. Also, the Vendor reserves the right to suspend sales or reduce the number of properties to be offered for sale at any time. person to the waiting queue does not guarantee that the registrant / person will be able to purchase any residential property.

(c) If the registrant has not purchased any residential property or if the number of residential property purchased by the registrant is less than the number of residential properties that registrant intends to purchase as indicated in the registration of Intent, the cashiers' order(s) which have not been used to effect part payment of the preliminary deposit will be available for collection by registrant in person or by an authorized person at the Sales Office from 1 February 2015 to 8 February 2015 between the hours of 11:00 a.m. and 8:00 p.m. If the registrant authorizes an authorized person to collect the cashier order on behalf of the registrant, the authorized person shall provide a copy of Business Registration Certificate or Certificate of Incorporation of the registrant (applicable to corporate registrant), a copy of the H.K.I.D. Card or Passport of the registrant (applicable to individual registrant), a valid authorization letter to the satisfaction of the Vendor and the authorized person's original H.K.I.D. Card or Passport.
